Amendments to Annex IV to the Staff Regulations of the Unified Patent Court

## **EXPLANATORY NOTE**

It is suggested to add a salary grid for the position as legal adviser of the President of the Court of Appeal and Legal Adviser for the President of the Court of First Instance. In order to attract applicants with the requested profile a net salary of said positions of 9 534 EUR is suggested. This amounts to 90 percent of the salaries of the Directors of the Patent and Mediation Centre and the Training Center.

HAVING REGARD to the Protocol on the Privileges and Immunities of the Unified Patent Court and in particular Articles 8 thereof;
