

## Case load of the Court since start of operation in June 2023 update 30 April 2025

### I. Court of First Instance

Since the Court's start of operations on 1 June 2023, the Court of First Instance has received a **total number of 836 cases.** 

- a. Infringement actions and counterclaims
- 305 infringement actions are filed as follows:
  - 103 infringement actions have been filed in Munich local division, 63 in Düsseldorf, 43 in Mannheim and 23 in Hamburg. 20 infringement actions have been received in Paris local division, 19 in the Hague and 15 in Milan local division. The Nordic Baltic regional division has received 7 infringement actions, Copenhagen has received 3 infringement actions, Paris central division, Brussels and Vienna 2 each, whereas Helsinki, Lisbon and Milan central division have received 1 infringement action each.
- 292 counterclaims for revocation have been filed with the Court's local and regional divisions. This figure however gives an inflated impression unless it is noted that that each defendant in an infringement case needed, up to a few months ago, to file an individual claim for revocation. The 292 counterclaims for revocation come from **167 individual infringement actions.**



#### b. Revocation actions

There is a total of **61 stand-alone revocation** actions filed to date with the Court. **Paris central division** has received **44 revocation** actions, **10 revocation** actions have been filed with **Munich central division** and **7** with **Milan central division**.

### c. Provisional measures


The Court of First Instance has received a total of **82 applications** for provisional measures, preserving evidence, orders for inspection and application for order to freeze assets.

### II. Court of Appeal

To date, the Court of Appeal has received 65 appeals under RoP220.1 (*litera* a or b), 41 appeals under RoP220.1 *litera* c, 83 appeals under RoP220.2 and 4 appeals under RoP221.


The Court of Appeal has also received **16 requests** for discretionary review, **20 applications** for suspensive effect and **26 applications** for an order for expedition of an appeal.

3 applications for rehearing under RoP245 have also been filed.


### III. Language of proceedings (CFI only - all proceeding types)
