

Case load of the Court since start of operation in June 2023 update end April 2024

I. Court of First Instance

Since the Court's start of operations on 1 June 2023, the Court of First Instance has received a **total number of 341 cases**.

a. Infringement actions and counterclaims

123 infringement actions are filed as follows:

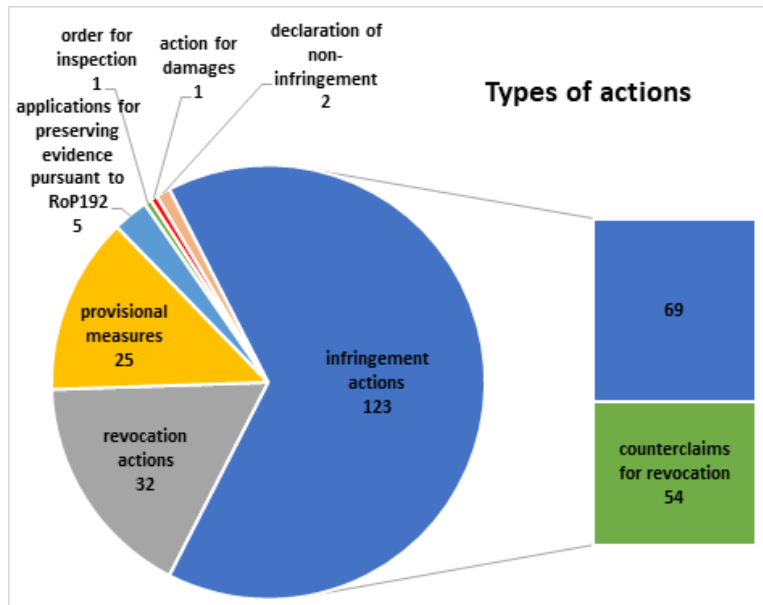
- 46 infringement actions have been filed in **Munich** local division, 25 in **Düsseldorf**, 16 in **Mannheim**, 10 in **Paris local division**, 7 in **Hamburg** division and 6 in the **Nordic Baltic regional division**. The local divisions of **Milan** and **the Hague** have received 4 infringement actions each, whereas **Brussel**, **Helsinki**, **Copenhagen**, **Vienna** and **Paris central division** have received 1 infringement action each.
- **153 counterclaims** for revocation have been filed with the Court's local and regional divisions. This figure however gives an inflated impression unless it is noted that that each defendant in an infringement case needs to file an individual claim for revocation. The 153 counterclaims for revocation come from **54 individual infringement actions**.

b. Provisional measures

The Court of First Instance has received **30 applications** for provisional measures, preserving evidence and orders for inspection.

c. Revocation actions

Paris central division has received **28 revocation** actions while **4 revocation** actions have been filed with Munich central division.



A further **detailed breakdown of the total caseload** of the Court of First Instance is shown in the table below.

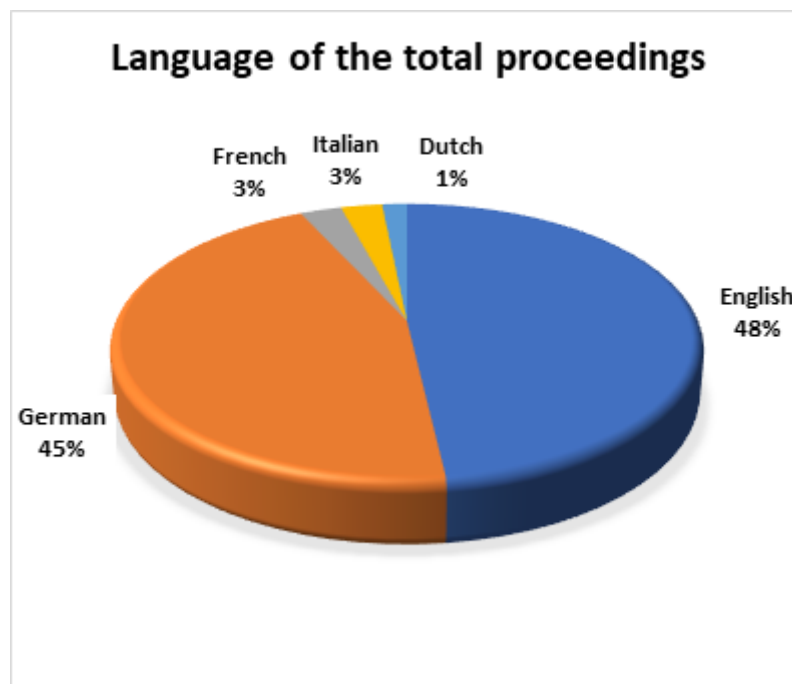
II. Court of Appeal

To date, the Court of Appeal has received **3 appeals under RoP220.1 (litera a or b)**; **11 appeals under RoP220.1 litera c** and **19 appeals under RoP220.2**.

The Court of Appeal has also received **two requests** for discretionary review, **two applications** for suspensive effect and **six applications** for an order for expedition of an appeal.

III. Language of proceedings (CFI only)

It can be noted that **English** becomes the predominant language of proceedings with **48 percent**. As to **German**, it currently makes up **45 percent** of language of proceedings at the CFI. A further breakdown of language of proceedings can be seen below:
