in the courtroom of the Local Division Hamburg A 156 in the Civil Justice Building
(Ziviljustizgebäude), Sievekingplatz 1, 20355 Hamburg.

This date has already been agreed with the parties' representatives.

REQUESTED PARTICIPATION OF THE PARTIES' REPRESENTATIVES

The parties' representatives are requested to inform the registry of the local division by email at contact_hamburg.loc@unifiedpatentcourt.org at least two weeks before the date of the hearing of the number of persons with which they intend to attend the hearing.

If individual parties intend to participate via video conference, they are also requested to inform the Registry of the local division by email within the aforementioned period. This can be provided via the Cisco Webex Meeting Solution.

It is also requested that the representatives inform the registry whether any - and if so, how many - spectators on behalf of the parties intend to follow the hearing in the audience area (see below under "Practical information").

INFORMATION ABOUT THE HEARING

The hearing is public unless the court decides to hold a hearing in camera, if necessary, in the interests of one of the parties or third parties or in the general interests of justice or public order (R. 115 RoP).

The hearing shall be conducted in **English**. The parties have the right to request simultaneous interpretation subject to the conditions set out in R. 109 RoP.

An audio recording of the hearing will be taken. The recording will be made available to the parties or their representatives after the hearing on the premises of the court (R. 115 RoP).

Around 30 seats are available in the hearing room for representatives of the press and the general public, whereof six are reserved for the press exclusively. There are currently no plans to implement an accreditation process. The seats will be allocated on a first-come, first-served basis, in order of arrival at the reception of the Court. No guarantee of a seat allocation can be given prior to the day of the hearing. Any press seats not allocated 10 minutes before the start of the hearing may be redistributed to the public. To ensure the calmness and quality of

the proceedings, late entries to the courtroom will not be permitted once the hearing has begun, except in exceptional circumstances.

Any **photography or filming** requires the prior permission of the President of the Hamburg Local Court as the holder of domiciliary rights.

Reference is made to the Chairman's order on the conduct of meetings (“Sitzungspolizeiliche Anordnung”) according to Rule 111 RoP dated May 22, 2024.

INSTRUCTION

Upon request, a default judgment may be issued against a party if a duly summoned party fails to appear at an oral hearing (R. 355.1 (b) RoP).

PRACTICAL INFORMATION

The courtroom of the Local Division Hamburg A 156 is located in the Civil Justice Building (Ziviljustizgebäude), Sievekingplatz 1, 20355 Hamburg, on the second floor directly above the main entrance.
