

The CMS' API allow the user's own software to interact directly with the CMS's backend for the creation of Opt-Out or Withdraw

There are two categories of APIs (Application Programming Interface):

- Application To Application (**A2A**): where the user's own program interacts and creates some entries in the CMS's database.
- Public API : where the user's program can retrieve some useful information regarding his cases, patents and related documents

This document focuses on the A2A API.

For the public API, we invite the reader to consult the dedicated documentation available on our corporate website (under the section "IT For developer") or click on the following link: [UPC Case Management System | Unified Patent Court \(unified-patent-court.org\)](https://www.unified-patent-court.org)

UPC's CMS is available for testing purpose on a dedicated environment. Within this environment, you are able to test your development before submitting your API call to the real production environment.

For each of API calls / functions available, we will provide you with:

- Type of request and a description
- The endpoint(s)
- The (main) input parameter(s)
- A sample of call ( http request or json file)
- A sample of result ( and depending on the result, the impact or visualization on the CMS frontend)
- A positive and negative result will be described also

This document is based on the last available SWAGGER / JSON file version 8 available on the UPC Corporate website under the section "For IT Developer".

### PRE-CONDITION

The user must own one API Key. This API Key can be obtained when the user is registered CMS user (he must have a defined account on the CMS). Once connected on the CMS, the user can request his Developer API Key via the menu "Support Center" – Developers- "My Developer App".

This API key is valid for one specific environment (for example one API key for the testing environment, and one another for the production environment). **This API Key value must be added within the "header" section of each A2A API Call and it is identified as "X-API-KEY".**

### Get Languages (used in the system)

**Type** GET

**Description** Get the languages available within CMS. Provides the list of all languages available within the CMS.

The language “list” contains the language(s) expressed as ISO code, and separated by “,” (a comma)

### Create one new OPT-Out

Type POST

Description Create one new OPT-OUT related to one provided Patent (*and related information*)

#### Change of behaviour compared to previous version

- Once you have submitted your opt-out / withdraw, you will get, as a result, a “technical” acknowledgement for the reception your “request” if this one is valid. The remaining internal processing of the request is now asynchronous.
- One new API request is available to get the status of your request : see detail in the next section

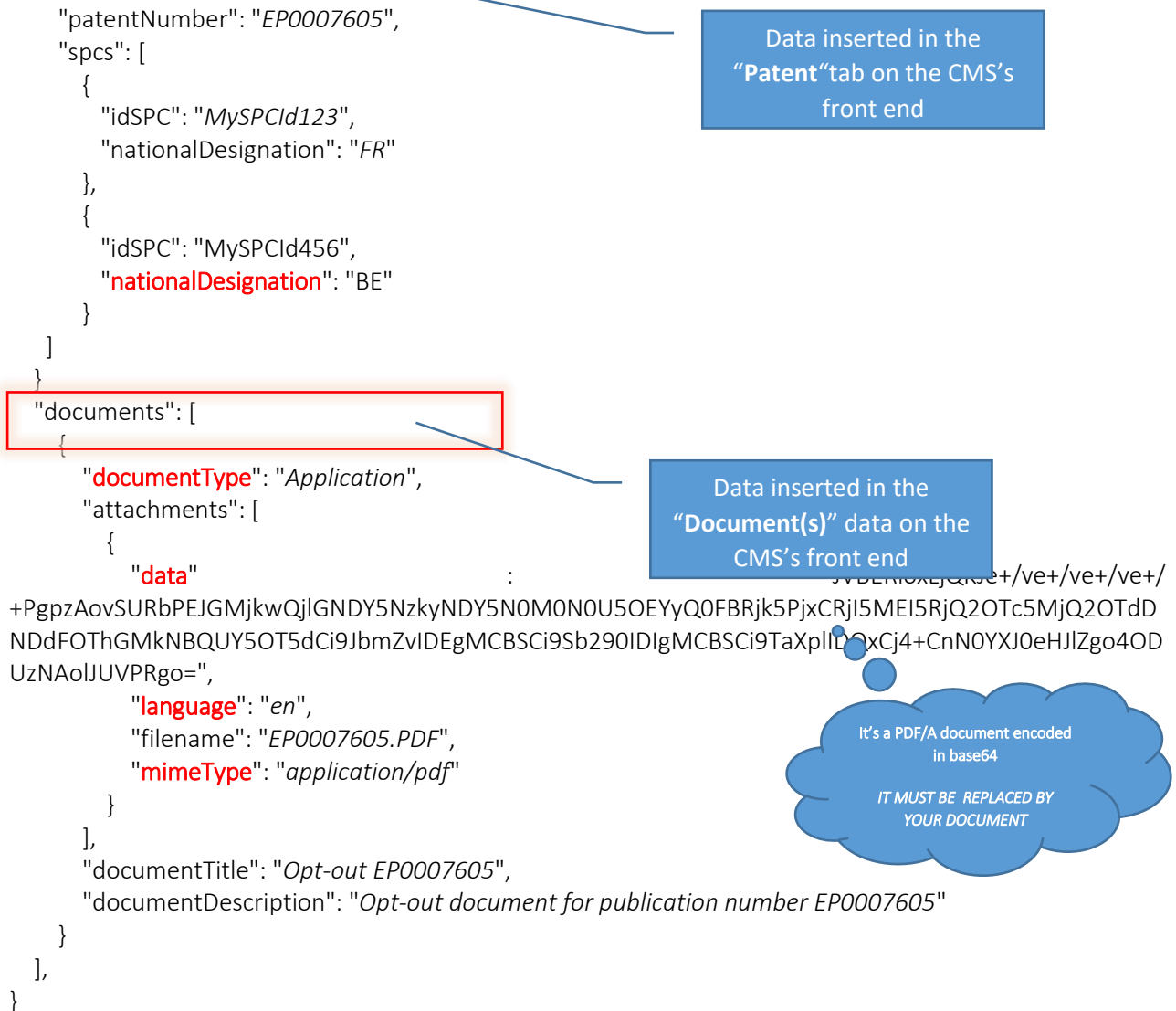

### Sample of result

#### Positive result. When everything went ok,

1. One request is created and the corresponding number (request identification) is returned directly to the user
2. The information / data related to the opt-out, is stored internally and will be processed (checks of the documents, generation of receipt etc...)
3. One mail notification will be sent at the end of the process to
  - o The applicant received one notification by email (email address mentioned under applicant json section)
  - o The "owner" of the API-Key should be a representative or one proprietor

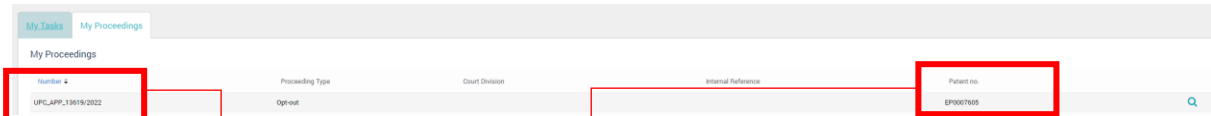


Figure 1 -Dashboard - My proceeding tab

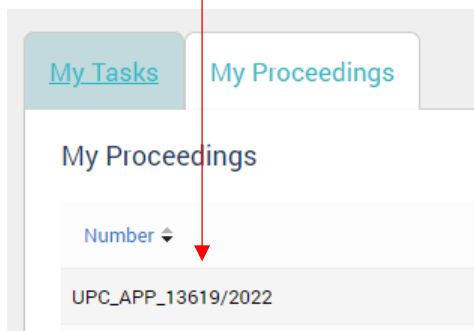


Figure 2 - Zoom on my proceeding number

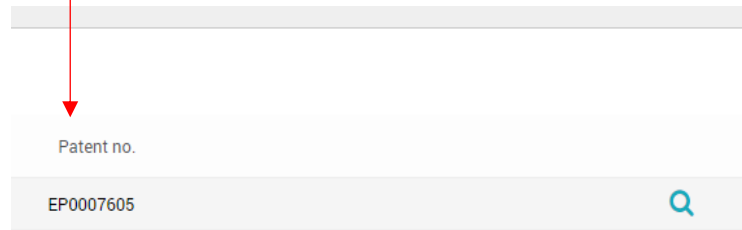


Figure 3 - Zoom on the patent(s) concerned by this opt-out

### Negative result

There are two categories of Error Code

- Error-Code 400 : When the “input” /provided value(s) is (are) not correct
- Error-Code 500 : when there is an “internal error” such as time-out

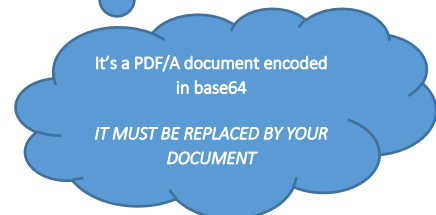


